Re: Election Code [Chapter 1 NMSA 1978]

Special Counsel,

The Special Investigations Division of the New Mexico Office of the Attorney General is currently investigating matters involving the submission of a document related to the 2020 Presidential Election affirming the state electoral votes. It has been reported that two separate electors convened and filed, or attempted to file, electoral votes for their respective candidates for the 2020 Presidential Election.

Our office requests certified copies of all documentation and evidence related to possible criminal acts committed in the State of New Mexico in regard to the attempt to overturn the Presidential Election conducted in 2020. Our office request included but is not limited to:

1. Email, cellular communication, electronic forms of correspondence or communication, all other records of communications and messages made or received by persons involved;
2. Any and all copies of the entire unredacted record, files and/or documents (in any form) associated with or regarding (directly, indirectly, or peripherally) any and all investigations/inquiries (internal, criminal, administrative, or otherwise conducted), disciplinary action (including any pending disciplinary action), public or internal complaints, referrals or complaints that have been made prompting or regarding the investigation and/or review of any incident involving person(s) attempt to overturn the Presidential Election conducted in 2020 in the State of New Mexico;



3. Any record documented on any media which appears to provide documentation, planning, instruction, advice, facilitation and/or otherwise support for the violation of person(s) attempt to overturn the Presidential Election conducted in 2020 in the State of New Mexico;
4. Any record documented on any media, which establishes and/or tends to establish the state of mind, motive(s), action(s), means, and/or intention(s) of any person(s) with the knowledge or apparent knowledge of the crime(s), including, but not limited to diaries, journal(s), audio and/or video tape(s);
5. Lists, writings, ledgers, or documentation (whether on paper or stored magnetic, digital, optical media, and/or e-mail) of any kind that contains any combination of numbers including dates of birth, social security numbers, driver's license numbers, or any other series of numbers that can be used to identify a specific person or account of any kind involving Jewll Powdrell, Deborah Maestas, Rosie Tripp, Anissa Ford-Tinnin, Lupe Garcia, Harvey Yates, John Eastman, Mark Caruso, Michael G. Smith, Nike Kern, and Thomas Lane;
6. Any and all items or property associated to any entity or organization or any enterprise purporting itself to be, being represented as, or otherwise give the appearance of being or conducting activities as a business to include but not limited to Jewll Powdrell, Deborah Maestas, Rosie Tripp, Anissa Ford-Tinnin, Lupe Garcia, Harvey Yates, John Eastman, Mark Caruso, Michael G. Smith, Nike Kern, and Thomas Lane;
7. Any document(s) (whether on paper or stored magnetic, digital, optical media, and/or e-mail) which appear to be related to the financial transaction(s) and/or attempted financial transaction(s) involving but not limited to person(s) attempt to overturn the Presidential Election conducted in 2020 in the State of New Mexico;
8. Any and all illegal or otherwise recognized evidence of a crime, believed related to the criminal activity, or had been obtained which is designed or intended for use or which has been used as a means of committing a criminal offense, and would be material evidence in a criminal prosecution regarding person(s) attempt to overturn the Presidential Election conducted in 2020 in the State of New Mexico;
9. All documents related to the certifying electoral votes for the respective candidate for the 2020 Presidential Election and attesting their respective candidate received the majority vote for the state of New Mexico and/or to award the five electoral votes for the 2020 Presidential Election. Furthermore, our office specifically requests certified copies of any complaints, lawsuits, notices, legal filings, or any other documentation associated with the certifying electoral votes for the 2020 Presidential Election.
